New Dancer Roundup John Cook

Successful

- 127 people in attendance
  - o In line with recent years, but down from past years
  - Lots of new students; lots of young people
  - o Proposal to keep new dancer round up in Anderson next year.
    - No issues with parking at that venue
    - Cost of venue is lower than prior venue
    - Some difficulties with audio in parts of the room. Will work on the sound for next year.
  - Used clothing give away was successful
    - Gave away about half of what was donated.
    - Petticoats went quickly; men's shirts also were popular
    - New dancers seem to like having used clothing available
  - \$51.00 was donated by one vendor.

National Convention John Cook

- Pre-convention was in Waco in March
- Facility looks good
- Texas people are enthusiastic
  - Danced on TV in San Antonio; video is on YouTube
- This year's convention in Shreveport should be good
- After Waco will be Loveland Colorado; expecting a bid from Daytona Florida for 2028.

Julia & Danny Branham Membership

- IDA has 25 clubs with 337 paid members plus several life members.
- Julie Branham proposes the approval of a new club
  - o The Nettle Creek Crusaders
    - Dances on Thursdays during the school year
    - Caller is Wesly Fenton
    - From Hagerstown Indiana
    - 24 people at organizational meeting; passed bylaws
  - o Bill Garrison seconds the motion
  - Motion passes by unanimous vote
- Membership still down from last year

- Discussion about appearing on TV on Channel 59 to discuss square dancing throughout the state
  - Have been on IndyStyle before
    - Requires getting up early in the morning
    - A lot of fun
  - Would be nice to have kids from new club to be on the show
    - Help people realize we aren't all old
    - Quite a few people under 20 at New Dancer Round up.

#### State Convention

Nadine Hutchison

- Next meeting in May
- Text Nadine ideas for themes and vendors
  - Clothing vendors are almost impossible to get at convention.

### OLD BUSINESS: Reorganization of IDA Areas

- Bylaw Committee seeks approval to rewrite the constitution and bylaws and present them formally in September to take effect by January 1, 2026.
- Committee recommends:
  - Reorganize IDA into one governing state-wide organization
    - Board of Directors to comprise:
      - One representative for each office
        - President
        - Vice President
        - Secretary
        - Treasurer
        - Past President
      - One representative from each IDA club
        - Must be an active IDA member to count towards quorum.
          - Only IDA members may vote on IDA business
          - Clubs must submit renewal paperwork by January 1 to be eligible to count towards quorum at January IDA meeting
        - Quorum will be 33% (Rather than the current 50%+1)
        - Officers cannot count as club representatives
        - Club representatives can only represent one club per meeting
      - Membership Committee to provide a list of all Active IDA clubs and members prior to each meeting.
        - Club representative must sign in using Zoom Chat to qualify towards quorum.
        - Secretary to count the signed in club representatives and officers to determine if there is a quorum.

- Discussion of what to do with area treasuries
  - Suggestion to give them choice of splitting money among clubs, giving to IDA general fund, or donating to a charity.
    - Area money comes from a combination of:
      - \$1.00 per member from state organization
      - Fundraisers and special dances
      - Hard to know how much money came from what source.
    - This is not and should not be part of the bylaws
- Define IDA clubs as dancing in Indiana
- Remove references to IDA News and Magazines
- Allow State Meeting to use electronic media for official business and remove the 5 day notification requirement for using electronic means
- Active IDA clubs need to submit their renewal paperwork by January 1.
- Julie moves for a vote on seeing a formal proposal of these ideas at the September meeting
  - Rick seconds
  - No one is opposed
